Supplemental Information – Priority Categories:

Supplemental Information for a specific renewable generation project:

Respondents submitting a specific renewable generation project by completing a *Core Information Spreadsheet* are encouraged, but not required, to provide supplemental information on that project by submitting an accompanying *Supplemental Information Form*. For such forms, NESCOE is particularly interested in receiving information in the following categories:

<u>Interconnection / transmission-related information:</u>

Part of the RFI process may include efforts to identify logical "clusters" of renewable energy sources that could benefit from a coordinated renewable procurement process. As transmission-related issues may be important to such projects, NESCOE would appreciate receiving interconnection and transmission-related information regarding proposed renewable generation projects. Examples of such information would include:

- For projects located in New England, indication of whether an interconnection request has been submitted to ISO-NE, and if so, whether a queue position has been assigned (and confirmation of the queue position);
- For projects located outside of New England (and to the extent known), indication of
 what transmission facilities, if any, might need to be developed (both within and outside
 New England) to reliably deliver the renewable energy output of those projects to New
 England loads; and
- Additional details on anticipated / potential interconnection points, voltages, etc.

Information on contemplated generation technology:

- Any information regarding the anticipated generation profile of an intermittent renewable resource (e.g., anticipated time-varying output from a wind project); and
- Additional information on any storage capability that would be developed in conjunction with the project.

Supplemental Information for transmission projects

As noted in the *Guidance to Respondents*, transmission owners and developers are encouraged to submit *Supplemental Information Forms* for transmission projects that may facilitate the delivery of energy from renewable generation projects to New England loads. Such "transmission specific" responses can either (i) be linked to specific generation projects (including projects for which a *Core Information Spreadsheet* has been submitted) or (ii) be proposed as "stand alone" transmission augmentations that would facilitate energy delivery from generic or unspecified renewable energy projects.

For *Supplemental Information Forms* associated with potential transmission projects, NESCOE would be interested in receiving non-confidential information about the renewable energy sources whose integration with the New England bulk power supply system would be facilitated by the project, and any technical information on the transmission upgrades. Examples of such information include:

- If applicable, an indication of the renewable generation projects whose energy output would be more readily deliverable to New England loads;
- Potential interconnection points, voltages, technology (e.g., AC vs. DC);
- Potential schedule for placing the project into commercial operation; and
- Other non-confidential information that may help NESCOE evaluate the information received in the RFI.

Respondents are encouraged to submit the supplemental information in whatever electronic format may be appropriate.
